In consideration of the applicant's participation in The PGA Section Championships, Qualifiers and The Junior PGA Championship: 1) the applicant and the parent/guardian hereby release The PGA of America, The PGA Section, PGA Tournament Corporation, Inc., Sycamore Hills Golf Club, host sites of PGA Section events and all of each company's respective officers, directors, employees, agents, subsidiaries and affiliates from any and all liability associated either with acts or omissions of such parties, or with accidents or injuries sustained by the applicant or parent/guardian in connection with the tournaments; 2) the applicant grants and assigns his/her individual media/photo rights respecting participation in the competition, without exception to the sponsors, PGA of America, PGA Tournament Corporation, Inc., and the PGA Section. Applicant information will be used for internal purposes only in conjunction with PGA of America activities and programs. Additionally, The PGA of America will provide event sponsors of the PGA Junior Series and Junior PGA Championship with the names and mailing addresses of its participants.

It is a condition of participating in this event that the competitor is not permitted to use a motorized golf car during the event competition. Notwithstanding the foregoing, The PGA of America is committed to conducting golf competitions within the parameters of the Americans With Disabilities Act. Players who request relief under the Americans With Disabilities Act and seek a reasonable accommodation for their disability by the use of a motorized golf car during the event competition shall be required to submit their request in writing to the Special Board on or before the entry deadline date for review and determination. The Special Board will schedule a hearing to allow the applicant the ability to present evidence to support the applicant's position.
